I identify the testatrix by means of her aforesaid Spanish Identity Card. I hereby certify that DOLORES MARTÍNEZ SÁNCHEZ is, in my judgement, of sound mind of her faculties to make, publish and declare this to be her NUNCUPATIVE WILL.-----

I GIVE, DEVISE AND BEQUEATH all my estate in equal shares and full ownership to my said eight children and to my said granddaughter. I appoint the descendants of the abovementioned heirs as alternate beneficiaries. -----

4. GRANT AND AUTHORISATION.-----

-I read this will aloud and the testatrix confirms that it is in accordance with her wishes and she signs it.
